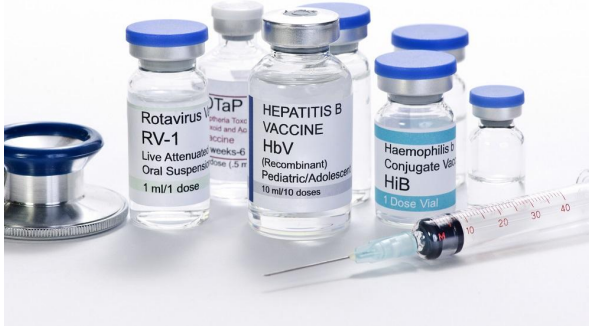

Sanofi:

Orders can be made directly with Sanofi by calling **1.800.VACCINE(1.800.822.2463)** or online at www.vaccineshoppe.com or www.vaxserve.com. Orders placed through VaccineShoppe qualify for an additional 1% online discount.

Merck:

Orders can be made directly with Merck by calling **1.877.829.6372** or online at www.merckvaccines.com or through a Merck Prime Distributor (i.e. McKesson, VaxServe, etc.). Please contact Merck for the full list of Merck Prime Distributors or see the full list at www.merckvaccines.com. For Merck orders that are placed through VaccineShoppe, there is an additional 1% online discount.

Pfizer:

Orders can be placed directly with Pfizer by calling **1.800.666.7248** or online at www.primevaccines.pfizer.com. Orders can also be placed through one of Pfizer's authorized wholesalers or distributors (i.e. McKesson, VaxServe, etc.). **Please note:** VaxServe currently charges a 4% markup fee for Pfizer products. While CCPAPP pricing is active on VaxServe, members will pay the additional 4% markup fee instituted by VaxServe. Therefore, it is recommended that members order directly through Pfizer to avoid fees.

[Sanofi's Beyfortus™ RSV Vaccine Now Available](#)

Sanofi's Beyfortus™ RSV vaccine is now available to CCPAPP members for discounted pricing.

Beyfortus™ (nirsevimab-alip) received FDA approval on July 17, 2023 for the prevention of respiratory syncytial virus (RSV) lower respiratory tract disease (LRTD) in newborns and infants born during or entering their first RSV season, and for children up to 24 months of age who remain vulnerable to severe RSV disease through their second RSV season.

[Pfizer's ABRYSVO[™] \(RSV Vaccine\) Now Available for CCPAPP Member Discount](#)

The ABRYSVO RSV vaccine is FDA-approved and ACIP-recommended to help protect both older adults and infants (via maternal immunization) from RSV.

RSV can lead to serious outcomes in older adults (annual data)

- ~2.2 million symptomatic illnesses
- ~60,000-160,000 hospitalizations
- ~6000-10,000 deaths

RSV is the leading cause of hospitalization in infants aged <1 year

- Hospitalization burden is greatest in infants under six months of age, peaking between one and two months of age.
- In severe cases, RSV may result in acute respiratory failure, hypoxia and carbon dioxide retention, apnea, and death.

CCPAPP pricing is now available for the Novavax COVID-19 Vaccine.

The Novavax COVID-19 Vaccine, Adjuvanted is a non-mRNA, protein sub-unit approved vaccine that may prevent COVID-19. The Novavax COVID-19 Vaccine, Adjuvanted is a monovalent vaccine that has been updated to the latest FDA identified SARS-CoV-2 variant for this fall.

The Novavax COVID-19 Vaccine, Adjuvanted is currently indicated as a seasonal immunization to prevent COVID-19 in individuals 12 years of age and older. For patients with no COVID-19 immunization history the Novavax COVID-19 Vaccine, Adjuvanted is approved as a two dose (0, 21 days) series for individuals 12 years of age and older.
