RETURNS AND CANCELLATIONS POLICY

Customers can return up to 15% of their total purchased doses of each vaccine presentation for full credit. Confirmed influenza reservations are non-cancellable.



SHIPPING COMMITMENTS

If Sanofi does not meet our in-season monthly shipping commitments for September and October, customers will be given an option to reduce or cancel the number of doses missed within the monthly commitment.

complete the reservation process by following the three steps below:

Step 1: Log onto www.vaccineshoppe.com and go to the Fluzone tab or call **1.800.VACCINE (800.822.2463)** by **March 31, 2023**.

Step 2: Review or adjust your reservation as needed (you may increase or decrease quantities or change presentations of your reservation).

Step 3: Review/update your contact information and delivery hours (if needed) and your reservation is confirmed.

If you are not currently enrolled in Sanofi's Recurring Reservation Program, you have until **March 31, 2023** to create your reservation.
