2024-2025 RSV season.

The Beyfortus Reservation Program will help to optimize planning and provide access to reserve Beyfortus ahead of the season. CCPAPP members can review the [Beyfortus Reservation Program Brochure](#) and [Prescribing Information](#) for more details.

### **How The Beyfortus Reservation Program Works:**

- 1. Forecast & Submit Your Dose** - Now through **April 30, 2024** work with your Sanofi representative to accurately predict and submit the amount of Beyfortus you will need using the Beyfortus Forecast Tool.
- 2. Reservation Period** - Place your order and schedule your shipment. The reservation period runs from **July 1 through August 31, 2024**.
- 3. Receive Your Reserved Shipments** - Deliveries begin late **August/early September 2024**.

### **How the program works**



### **Benefits of the Beyfortus Reservation Program Include:**

- Priority shipping with reserved doses set aside.
- Ability to determine your preferred monthly shipment schedule throughout the RSV season.
- 90-day payment terms.
- Cancellation is possible up to 14 days prior to scheduled shipments.
- Returns are also accepted on expired product.

### **The Reservation Program has Benefits, but it's not Your Only Chance to Order:**

Orders can be placed outside of the reservation program during the normal order window from September 2024 through February 2025.

- Normal ordering window terms and conditions:
  - Order Now/Ship Now Only: No ability to schedule future shipments.
  - Payment terms are limited to 60 days.

### Prevnar 13<sup>®</sup> to be Discontinued by Pfizer

Effective **April 30, 2024**, the **Prevnar 13<sup>®</sup>** National Drug Codes (NDCs) listed below will be discontinued by Pfizer:

### Pfizer's Return Goods Policy:

- Pfizer's Return Goods policy will apply until April 30, 2024.
- After April 30, 2024, Pricing Services will "discontinue" the NDCs for Prevnar 13<sup>®</sup> in their system, which will update payer and provider systems. As a result, Prevnar 13<sup>®</sup> will likely no longer be reimbursed by payers. Per our Return Goods policy, all discontinued product is returnable for credit regardless of expiry, up to one year beyond labeled expiry date.

The number of doses that an individual practice may return shall not exceed **15%** of the doses for each individual product purchased. Products are defined as follows:

Returnable doses shall include only:

1. Unused and unopened multi-dose vials.
2. Full boxes of unused prefilled syringes.

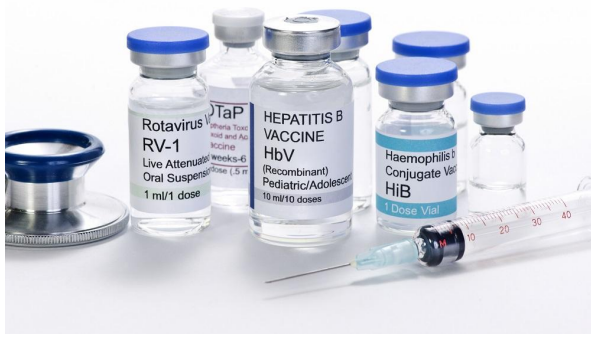

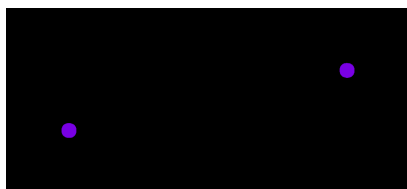
